OVERVIEW OF THE SALT LAKE COUNTY BOARD OF HEALTH AND HEALTH DEPARTMENT:

Gary reviewed the Board of Health authority, governance, and responsibilities outlined in a handout distributed during the meeting. He explained two ways to think about public health issues; governmental public health, which includes the Utah Department of Health and Local Health Departments; and public health systems, which includes healthcare facilities, providers, public safety, schools, and other services on a broader scale.
