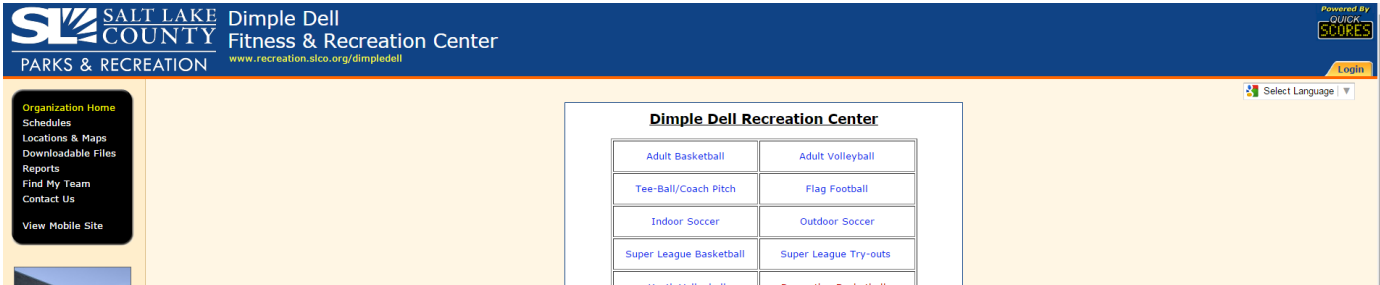
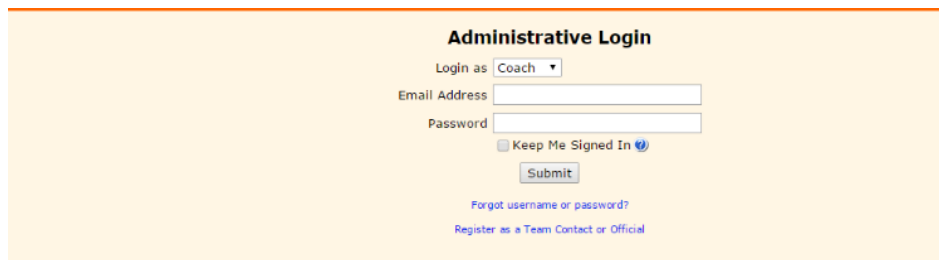


Registering for QuickScores and Uploading your Team Roster

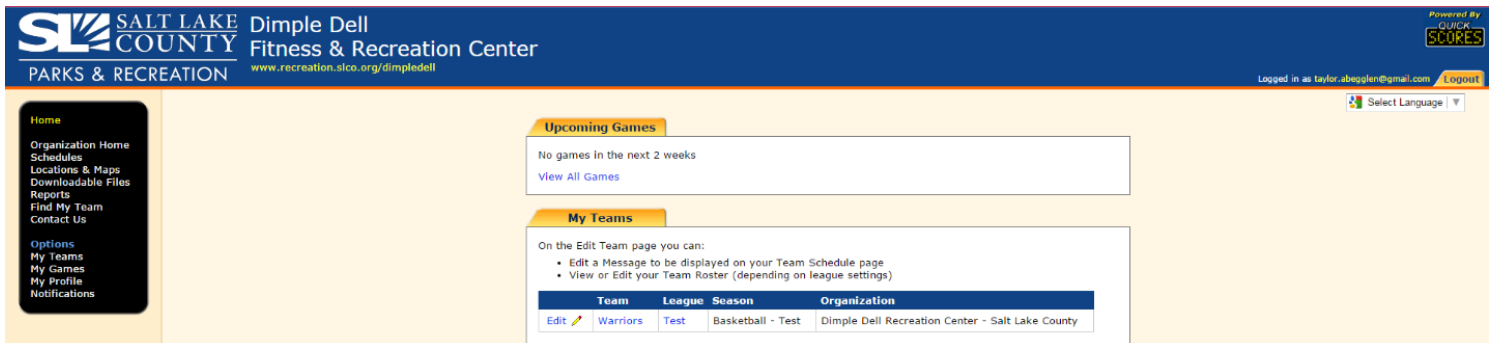
1. Head over to Quickscores.com/dimpledell



2. Find Login button in the top right corner.
