## Item #1-Call to Order.

## Paulina Flint called the meeting to order.

#### Item #2- Conflict of interest disclosure.

Action Requested: Identify Conflicts; if any

Discussion: Trustee Flint asked if there were any conflicts of interest. None were identified.

### Item #3-Public Comment.

Trustee Flint asked if anyone was calling in to the meeting or was present who wanted to give public comment to the Board. Marcie Kay, SLVLESA Clerk, stated that there were no calls from the public. No one present wanted to give public comment. Public comment was closed.

**Discussion:** Richard Moon said there were three checks for the month of May, which are listed on the check register. He asked if there were any questions regarding that. There were none.

## Item #5-Discuss Selection of Financial Advisor.

#### Action Requested: None

**Discussion:** Frank Nakamura said SLVLESA's contract with Zion public finance, who has been their financial advisor, primarily on the TRANs, expired in May. They are now doing an RFP for a financial advisor for a 5-year contract. He asked if there were Board members who would like to serve on a procurement committee, along with Lisa Dudley and Richard Moon. He said that Trustee Bradley has already volunteered to be on the committee. Item #6-Consider RESOLUTION NO. 21617-1 OF THE BOARD OF TRUSTEES OF THE SALT LAKE VALLEY LAW ENFORCEMENT SERVICE AREA (SLVLESA) ADOPTING AN AD VALOREM RATE OF TAX LEVY FOR CALENDAR YEAR 2021 ON PROPERTY MADE TAXABLE BY LAW IN SLVLESA BASED ON SLVLESA'S BUDGETED PROPERTY TAX REVENUE FOR CALENDAR YEAR 2021.

## Action Requested: Motion, Second, and Vote.

**Discussion:** Lisa Dudley said every year they must wait for the certified tax rate to become available. She said this year they needed to wait or the state and the county to determine the rate, but they did present it on the State certified tax system in final form yesterday. This year, because SLVLESA did not hold truth-in-taxation in the fall, the Board made the decision to accept the certified tax rate for calendar year 2021. The certified tax rate that was calculated through that process by the state and auditor's office is .001973 and that is anticipated to generate property tax revenue of \$17,597,723. When that is approved by the Board, after their discussion, they then would file it online with the state auditor's office, on the tax rate website.

# Item #7-Consider RESOLUTION NO 21617-2 OF THE BOARD OF TRUSTEES OF THE SALT LAKE VALLEY LAW ENFORCEMENT SERVICE AREA (SLVLESA) ACCEPTING THE INDEPENDENT AUDIT OF SLVLESA FOR CALENDAR YEAR 2020 AND ORDERING THAT IT BE FILED WITH THE UTAH STATE AUDITOR.

## Action Requested: Motion, Second and Vote.

**Discussion:** Lisa Dudley said one of our auditors was on Zoom and his name is Todd Sullivan with HBME. He was the audit manager and was responsible for the field work. Aaron Hixon was the reviewing partner. Lisa Dudley said SLVLESA's audit work is a lot less involved than UPD's. There are fewer transactions and nearly all are electronic and that makes for better safeguards. Lisa Dudley said she wanted to thank the auditors because they have been great to work with. Todd Sullivan presented to the audit report to the Board Chair, Trustee Bradley, Lisa Dudley, Richard Moon and Frank Nakamura earlier this week. Todd Sullivan from HBME said Aaron Hixon could not make it to the meeting today. He referenced his audit report, which was sent digitally to the Board members. He said they issued an unmodified opinion that the financial statements are reasonably stated, they did not find any material financial issues and like Lisa said the control environment is very safe due to the nature of the transactions being electronic and the small volume of transactions. The net position for SLVLESA increased resulting in a \$5.67 million fund balance at year end. Revenues were similar over the prior year. He said expenses were kept under budget, which was good.

He said they did find one issue that they wanted to address, and they discussed with Lisa Dudley and Frank Nakamura. They decided it would be okay to have a verbal finding on the issue they found. He said there was a Board training that needs to be done by the Board every three years for state and local districts and they found that one Board member had not completed the training. That Board member was no longer on the Board and they had reviewed documentation that Frank had gone over with the Board member to bring them up to speed. He said because that Board member is no longer on the Board and everyone else has received the training, they decided to go with a verbal finding. He said if next time they review it and they have even one Board member that has not received the training, they will do a full written finding.

Lisa Dudley said she wanted to make it clear that this is the state auditor's Board training, and this is different from the annual open and public meetings act training. She said it is good for several years, but they need to be aware of the expiration date so that it is repeated in a timely manner. She said the training is available online, it does not have to be in-person. She said Frank Nakamura does have the certificates for those that are current.

Frank Nakamura said he will monitor the expiration dates. He said the easiest way to complete the training is to go to the Utah State Auditor's website. He said he will discuss with the Board in the future if they want to do the open and public meetings act training at one of the SLVLESA meetings. He said the Open and Public Meetings Act training must be done annually and the Board training every three years. He said all existing Board members are in compliance.

Trustee Flint entertained a motion to pass the Resolution.
