WHY MOVE TO SCIQUEST?

The current cooperative contract for the County's e-Procurement system, BidSync, expires in March, 2017. The County utilizes State of Utah Cooperative Contracts where practicable. The new Utah State Division of Purchasing cooperative contract is with SciQuest. SLCo Contracts & Procurement will be utilizing the SciQuest cooperative contract for its e-Procurement system and is in the process of transitioning over to SciQuest as a replacement to Bidsync.



SciQuest Benefits:

- No cost to vendors to register and receive bid notices from SciQuest
- Marketing information from SciQuest will not be sent to vendors
