The Market at Wheeler Farm is a **SUNDAY MARKET**, the Market runs **June 3rd-October 28th** for the 2018 season for a total of 22 Market Days. Vendors are expected to stay for the FULL market operating time—hours are 9:00am - 2:00pm each Sunday. Please refer to the Wheeler Farm Sunday Market Vendor Handbook for rules on inclement weather, set up, and break down. If vendors plan to attend all the Market Days, the cost is \$5 per day for a flat \$110 annual fee for PRODUCE/GROWER ONLY vendors. Drop-in rates for produce vendors are \$10 per day.
