CDBG funds will be used for design and construction of street improvements on 12660 South beginning at Redwood Road or 1700 West and going east to 1630 West, then South on 1630 West as funding will allow. This project involves the installation of curb, gutter, sidewalk and other infrastructure associated with developable property in Riverton City's Redevelopment Area. Riverton City has partnered with a preferred developer and is in the final stages of approval of a multi-family housing project within the Redevelopment Area. This project will bring a greater diversity of housing choices to the area, and will include a mix of traditional townhome and detached patio home units. The addition of the improvements funded through CDBG will provide better pedestrian access to the area and will allow for more cost effective redevelopment, and the associated landscaping and street trees will help to create a more sustainable project and improve the streetscape.

Of the total served in Q2, 19 clients were newly admitted in Q2, and received 486 housing days. 3 were Hospice clients and 16 were Respite clients. They continued to serve 14 clients who carried over from Q1, providing them with 646 housing days in Q2. Of these, 7 were Hospice clients, 7 were Respite clients, 5 died with dignity at The INN Between, and 1 former client died off-site died (they had helped him apply for and secure housing at the VA's Freedom Landing, and he moved from The INN Between to his new home in Q1. He was able to spend the end of life in his own place, receiving hospice care).
