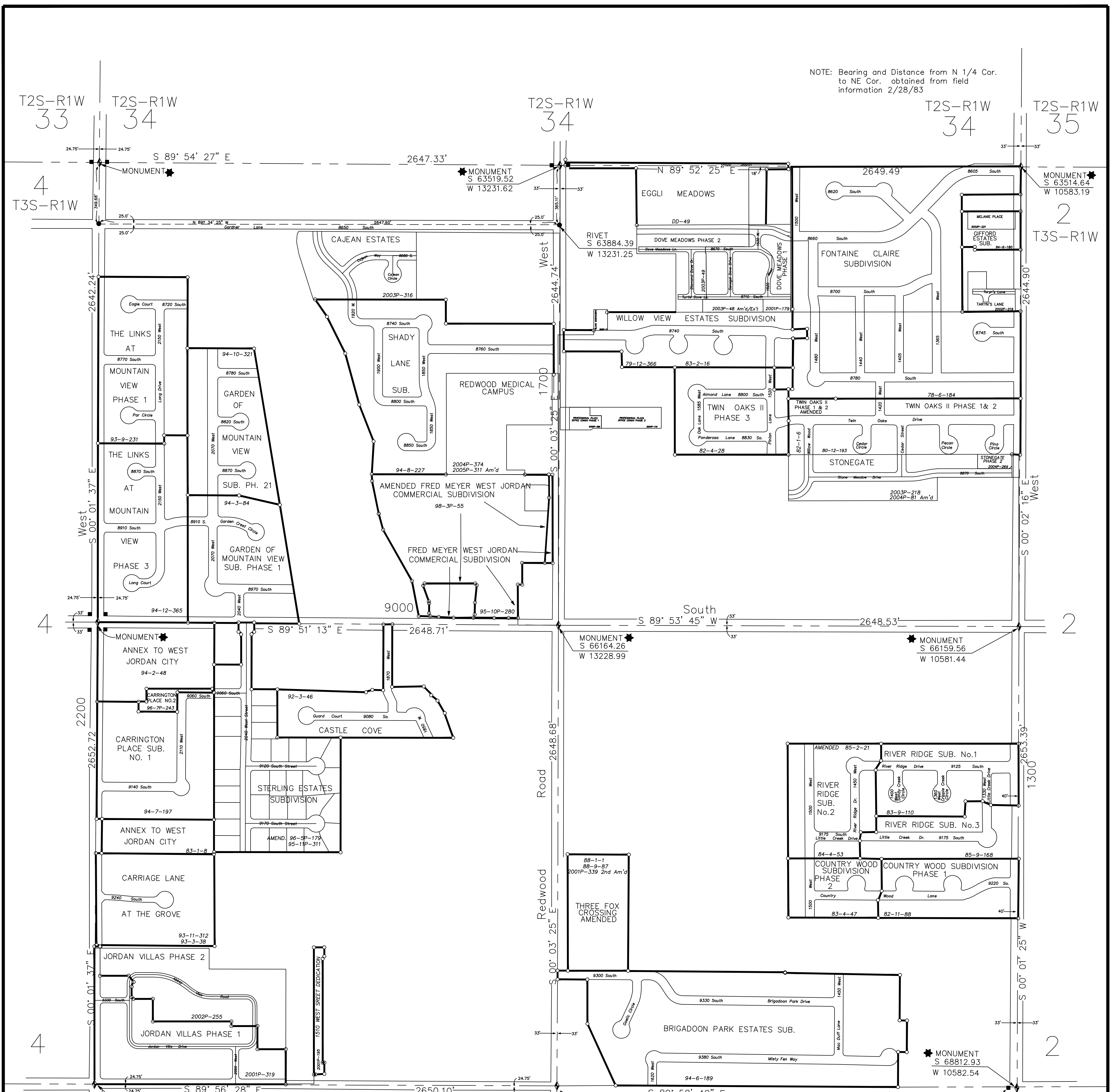


NOTE: Bearing and Distance from N 1/4 Cor. to NE Cor. obtained from field information 2/28/83
