**2018 PREPAYMENT PROGRAM**  
Application Card Due: November 30, 2017



Hello....SLCo provides the option to prepay estimated current year property taxes in monthly installments, rather than paying the full amount in November. Sale or transfer of property ownership will require settlement of prepayments between seller and buyer at closing. **Prepayments will be applied to the current tax year only.**

The monthly payment amount is determined by dividing the 2017 tax amount into nine (9) equal payments made from January thru September. Payment may be made by ePAY via electronic bank withdrawal or by paper with preprinted coupons and checks. The final payment can be made by the taxpayer or if using ePAY select "Final

Pay" and it will be made electronically.

Any remaining balance due or overpayment will be reflected on the 2018 Tax Notice. All payments must be \$10 or more.

**PAPER OPTION**

**COUPON PAY:** Booklets will be mailed in December for use from January thru September. Monthly coupon amount will be your 2017 taxes divided by 9 months. Any final balance or overpayment will be reflected on your official Property Tax Notice.

**ePAY OPTION** *(Electronic Payment via Bank Withdrawal)*

**9 PAY:** SLCo makes nine (9) electronic bank account withdrawals *(2017 taxes/by 9 mos.)* and you will pay the final balance unless the "Final Balance" box is checked below.

**MYPAY:** Charge my account in the amount of \$ \_\_\_\_\_ per month and I will pay the remaining balance unless the "Final Balance" box is checked below.

**Final Balance Electronic Payment:** By checking this box I authorize SLCo to make a final withdrawal for any remaining balance due on November 30, 2018.

**Banking Information for ePay Option above:**
