Program Rules

Please review and follow all guidelines on the Parent Information Sheet with your child.

1. This program is not sponsored by the school or Canyons School District. Call Salt Lake County Dimple Dell Fitness and Recreation Center at (385) 468-3355 with questions.
2. Transportation is provided by chartered busses. Students may not ride in family or friends vehicles to or from Snowbird. NO EXCEPTIONS.
3. Requests to ski or ride with specific individuals are guaranteed.
4. Missed lessons **cannot** be filled by a friend or relative. No refunds will be given once the program has started. No make up days for missed sessions. Parents are required to notify the Dimple Dell Fitness and Recreation Center when a child will miss a session to prevent staff from trying to locate them and get a late start. (385) 468-3355
5. Individuals are responsible for providing their own ski/snowboard equipment or arranging their own rentals. Please check equipment to ensure proper sizing and condition. Dimple Dell Fitness and Recreation Center is not responsible for injury due to equipment failure.
6. Label all equipment (skis, poles, snowboards) and personal items **clearly** with the child's name. Dimple Dell Fitness and Recreation Center is not be responsible for lost or stolen items.
7. Failure to adhere to these rules or inappropriate behavior may result in student being dropped from the program without a refund.
8. If a session is cancelled due to adverse weather or road conditions, the make-up day will be held on the above mentioned make-up days. Please read cancellation policy regarding multiple cancellations.

Salt Lake County Wednesday & Friday After-School Ski Cancellation Policy

Program is designed to provide five or six lessons. In the event of cancellation due to weather, road conditions, resort closures or other circumstances deemed out of the control of Salt Lake County Parks & Recreation, lesson will be made up on the above mentioned make-up days.. All costs associated with the **first** cancellation will be absorbed by the County, including transportation and staffing. Should more than one cancellation occur the County will not provide additional make up days or reschedule additional lessons. A refund of \$25 per lesson that cannot be rescheduled will be issued to each participant. No other refunds will be issued to participants. This policy is necessary due to limited buses within Salt Lake County, the numbers of participants in this County wide program, and the unpredictability of Utah winter weather.

SKIER

- RED:** Never skied before
- YELLOW:** Can make slight turns on beginner slope
- GREEN:** Can link turns on easy runs
- BLUE:** Can make mostly parallel turns on all blue runs
- BLACK:** Can make carved, short turns on black runs and seek off-trail conditions

SNOWBOARDER

- RED:** Never snowboarded before
- YELLOW:** Can heel slide, stop, and working on turns
- GREEN:** Can link turn on green and easy blue runs
- BLUE:** Can link turns and ride all blue runs comfortably
- BLACK:** Can link turns on black runs, seek off-trail conditions, and may be doing jumps/tricks

Parental Statement of Agreement – Assumption of Risk, Liability Release and Refund Policy

- 1) **Assumption of Risk:** I hereby acknowledge and agree that my child's participation in recreational activities involves inherent foreseeable and unforeseeable risks and hazards which may expose my child, or me, to illness, injury, or death. In consideration of my child's participation in such activities, I for myself, my child, my heirs, my executors and administrators, freely and voluntarily agree to assume and accept any and all risks to my child or myself associated with my child's participation in Salt Lake County recreational activities.
- 2) **Release:** In consideration of my child's participation in the Salt Lake County recreational activities, I, for myself, my child, my heirs, my executors and administrators hereby release Salt Lake County and its officers, agents, and employees from any cause of action, claim, or demand of any nature whatsoever I or my child may now have, or have in the future, against Salt Lake County on account of personal injury, property damage, death, or accident of any kind, caused by, arising out of, or in any way related to my child's participation in Salt Lake County recreational activities.
- 3) **Indemnification:** In consideration of my child's participation in the Salt Lake County recreational activities, I agree to indemnify and hold harmless County, its officers, agents, and employees from any and all causes of action, claims, demands, losses, or costs of any nature whatever cause by, arising out of, or in any way related to my child's participation in the Salt Lake County recreational activities. I agree that my duty to defend and indemnify the County under this Agreement includes all attorney fees, litigation and court costs, expert witness fees, and any sums expended by or assessed against the County for the defense of any claim or to satisfy any settlement, arbitration award, or verdict paid or incurred on behalf of the County arising out of or in any way related to my child's participation in the Salt Lake County recreational activities.
- 4) **Refund:** Refunds may only be requested in person and must be accompanied by a written request. As per Salt Lake County policy and procedures the Parks and Recreation Division may withhold 25% of the refund (program registration fee) for administrative costs. No refunds shall be given after the first day of the program.
- 5) **Collections:** I agree to pay Salt Lake County all costs incurred, together with reasonable attorney's fees in the event that my account is referred for collection. I understand that any account delinquent 30 days or more will be turned over to collection.
- 6) **Emergency Treatment:** I hereby authorize Salt Lake Parks and Recreation program staff to act on my behalf in accordance with their best judgment in case of an emergency involving my child, and agree to assume full responsibility for all expenses, medical or otherwise, that may arise therefrom.
- 7) **Media Consent:** I hear by grant permission to Salt Lake County to use my or my children's photograph, videotaped image, quotes/comments, or name for publicity and educational purposes in any and all publications and media without limit or compensation.
- 8) **Name Posting:** Unless otherwise indicated below, Salt Lake County is authorized to post or publish the name of my child participating in Salt Lake County recreational activities on the Salt Lake County website.

I do not authorize Salt Lake County to post or publish the name of my child participating in Salt Lake County recreational activities on the Salt Lake County website. By signing this assumption of risk, liability release, and refund policy statement, I acknowledge that I have read its contents and disclosure, that I understand its contents and disclosure, and that I agree to its terms. If any portion of this Agreement is held to be invalid by a court of law, then it is agreed and intended that all the remainder shall, notwithstanding, continue in full force and effect.
