- T-Shirts for the 1st place team in each division.
- The ISI fee is included in the team fee and will cover Players and Coaches.
- For ISI Insurance , teams will be required to select a team name listed below.
(Squirt Division - Ducks, Canucks, Wild, Predators, Golden Knights, Kings, Sharks, North Stars)
- Teams must provide their own matching color jerseys. Pullovers will be available if needed.
- Player must play in their appropriate age division. Players may play up a division.
- Teams may roster up to 9 skaters (maximum 4 select/travel skaters combined), 1 goalie (not included as select/ travel skater) and 2 coaches. Your team must have a minimum of 7 skaters, a goalie and 1 coach.
- Games will be played Friday evening, March 23th and all day Saturday, March 24th.
- Tournament schedule will be available by March 12th, 2018.

11th Annual Spring 3 on 3 Cross Ice Hockey Tournament



1. Tournament Philosophy

- The philosophy of 3 on 3 Hockey is to bolster skills such as passing, shooting, and team play in a fun and recreational setting.
- Every effort is made to ensure fair play, sportsmanship among players and coaches.
- Equal opportunity is stressed for every player.

2. Game & Tournament Format

- Each time slot is 1 hour and 15 minutes.
- Each time slot will begin with a 5 minute warm-up.
- Each game will have two 15 minute periods, **running-time** with a 1 minute break between periods. Teams will switch ends at the end of the first half of each game.
- Teams will play 2 games against a different opponent within the 1 hour and 15 minute time slot.
- Each team will be guaranteed 6 games including playoff round.
- Each game will have one referee.
- The referee is responsible for calling penalties, and overall game management.
- A game supervisor will oversee the general management of the games.
- T-Shirts for the 1st place team in each division.

3. The Rink

- The ice surface is divided into 3 sections. Games are played in each end from the blue line to the end boards and cross-ice.
- The neutral zone acts as a player's bench, coaches and officials area.
- Across each blue line will be a 12 inch high barrier to help keep pucks in play.
- Nets will be placed approximately 4 feet from the side dasher boards.

4. Rules

- No checking or slap shots.
- No fighting. Anyone involved in a fight will be suspended from the tournament.
- All penalties result in a penalty shot for the offended team (this includes slap shots).
- Any player receiving a major penalty will be suspended from the tournament.
- Face-offs are only held after goals, penalty shots, pucks leaving the playing area and the goalie freezing the puck.
- All face offs will be at the center of the playing area.
- Change on the fly from designated "change zone" only. This area, approximately from the neutral zone off-side dots to the boards, acts as the player's bench.
- If the game is tied after regulation there will be a 3 man shootout. If the game is still tied then it will go into a sudden death shootout, which means if one team scores and the other team fails to score then the game is over. Each team must go through four skaters before starting through their line up again. A coin toss will determine which team shoots first. In playoff rounds higher seed team shoots first.
- Any and all rule interpretations/clarifications will be decided by tournament director/official on site.

5. Teams

- Each team will consist of 7-9 skaters (maximum 4 select/travel skaters combined) and one goalie (Goalie not included as a select/travel Skater).
- Each team must have at least one Coach.
- Teams must provide their own matching color jerseys. Pullovers will be available if needed.

6. Referees and Scorekeepers

- Officials contracted through (WIHOA) and scorekeepers for each game.

7. Equipment

- Full ice hockey equipment is required for players.
- Coaches must wear a hockey helmet while on the ice, skates are optional.
