# 2) Other Business Items (as needed)

Patti Hansen with Oquirrh Recreation and Parks District said they have been in negotiations with Utah Olympic, looking at three documents, long term lease for the oval, ground lease under the KTEK building, and a declaration of condominium partnership owning the building. 2016 parcels were combined, oval negotiations surrounding land underneath the oval. Under KTEK will be the ground lease and foundation will enter into an agreement with them.

Mr. Woodward said section in zoning for public uses, you as a planning commission have authority to allow lots smaller than minimum acreage and waive or alter setbacks to a property line. The Planning Commission has authority to approve that because it is a public use.

**Comments:** Mr. Croxford said the project is proposed right across the street and vacated by maintenance staff. 15,000 square foot head start program, school use and wellness clinic. Existing buildings will be torn down, now vacant. Included outlines of existing buildings they are proposing.

Commissioner Wellman motioned to close the public hearing, Commissioner Hatch seconded that motion.

Wellman asked how many children would be enrolled. Jennifer Godfrey, CEO said there would be 124 children, from surrounding schools and currently in modular units and will come to new facility. Ms. Godfrey said there would be 25 parking spaces are enough. She doesn't believe traffic flow will affect it, they will do shared parking. Commissioner Wellman asked about the wellness clinic will anyone that wants to walk-in and IHC clinic, small kiosks, once library is open, they will have shared parking. They are hoping to be operational in August 2019. Commissioner Hatch said the playground will be southeast.
