Locations and Discussion Items

Depart at approximately 12:00 p.m. It is possible that, depending on traffic, weather and road conditions, that parts or all of the Traveling Tour could be canceled. If only Big Cottonwood Canyon is open, the Traveling Tour will proceed in Big Cottonwood Canyon only.

First stop: North Fork Trailhead (Donut Falls)
Discussion items: trailhead usage and parking

Second stop: Solitude Resort, Moonbeam lodge parking area and adjoining buildings
Discussion items: resort base items (land uses, parking, transit, etc.)

Third stop: Silver Lake Visitor’s Center and walking to residences to the south on Willow Loop Rd.
Discussion items: setbacks, vegetation, etc.

Fourth stop: Brighton Resort parking lot and adjoining buildings
Discussion items: resort base items (land uses, parking, transit, etc.)

Stops 1 – 4 could take place any time between 12:30 – 4:30 p.m., depending on weather and traffic conditions. The Traveling Tour will be transported on a Utah Transit Authority tour bus (not a ski bus).

Fifth stop: Snowbird Resort, Snowbird Center parking lot, touring different areas of the resort base.
Discussion items: resort base items (land uses, parking, transit, etc.)

Target arrival/departure time: arrival could be as early as 3:15 p.m., and departure could be as late as 4:45 p.m. It is also possible, depending on weather and traffic conditions, that the Traveling Tour does not go to this Fifth stop.

Possible Sixth stop: White Pine Trailhead parking lot
Discussion items: trailhead usage and parking

Target arrival time: arrival could be as late at 4:45 p.m. It is very possible that the Traveling Tour does not go to this Sixth stop.
