Re: **Addendum to Financial Disclosure Report filed electronically on January 27, 2007**

It appears that a problem with the online financial disclosure application resulted in the loss of the carry forward Year To Date data on my final report for the 2006 year. As you know, the Column B Year To Date data included in the Summary schedule is provided automatically by the application based on previously filed reports. A candidate cannot enter Year To Date data when the electronic reports are filed in order to insure the integrity of the contributions and expenditures reported. It appears that the Year To Date values were either lost or reset to zero on my report between October 30, 2006 (the filing date of the immediately preceding report) and January 27, 2007.

Accordingly, I am filing this **Addendum** to provide the correct values for the 2006 reporting year.

According to my records, **Line 1 Column B should show \$17,951.97.**

According to my records, **Line 2 Column B should show \$15,079.26.**

**Please note that both amounts shown above include the correction for Campaign Expenditures properly reported to the County Clerk as of March 31, 2006 in the amount of \$894.85 which amount was improperly netted against Year To Date Contributions on the October 31, 2006 report resulting in an understatement of both Year To Date Contributions and Year To Date Expenditures.**
