

## Big Water Yurt Rules of Occupancy

1. No refunds or credits will be given.
2. Reservations may not be transferred to third parties. The Responsible Party information on the account that makes the reservation **must** be the person who will be utilizing the yurt. Please print a copy of your receipt and permit when you make payment for the reservation.
3. No motorized vehicles are allowed beyond the winter gate at Maple Grove.
4. Up to 2 dogs are allowed at the yurt during the months of **January** and **March** only. Dogs are not allowed at the yurt during the months of **December, February** and **April**.
5. Dogs must always be leashed in picnic areas, parking lots, roads and any developed areas. Dogs may be off-leash on odd-numbered days on the upper trails only. Responsibly dispose of your dog waste properly.
6. A maximum of 8 people are allowed.
7. Fires need to be extinguished with water at the end of your stay. All ash needs to be removed from the stove and put into the ash can. It is unlawful to leave anything burning.
8. Check in time is 1 pm. Check out time is 12 noon the next day. Please leave the yurt clean.
9. Split wood for the stove is provided outside on the wood stand. Please restock inside wood supply for the next party before leaving.
10. It is your responsibility to shovel snow away from the yurt door and restroom doors during heavy storms (snow shovel is provided). Maintenance may not be available for a couple of days.
11. There is no garbage service in Mill Creek Canyon. Please "pack it in, pack it out." Do not leave food or drinks for others.
12. RESPONSIBILITY FOR BREAKAGE OF OR DAMAGE TO THE PROPERTY DURING USE BY YOUR GROUP WILL REST WITH THE RESPONSIBLE PERSON OR PERSONS.

The U.S. Forest Service has published a Big Water Yurt flyer. The flyer describes what facilities are at the yurt and what you need to bring to the yurt. The flyer also contains other useful and safety information.

**KEY PICK UP:** You, as the Responsible Party, must pick up the key to the yurt from the Parks office, leave a refundable \$75.00 deposit (**credit cards only**) and sign the Forest Service use agreement and permit:

- \* The Parks office is located at 6332 S. Airport Road (4570 West) in West Jordan.
- \* The Parks office is open Monday through Friday from 8 am to 5 pm except on the following County holidays:
  - Thursday, November 28, 2019 and Friday, November 29, 2019
  - Wednesday, December 25, 2019
  - Wednesday, January 1, 2020
  - Monday, January 20, 2020
  - Monday, February 17, 2020
- \* You may come to the Parks office on the morning of your reservation or on the previous business day. If your reservation is on a weekend or a Monday holiday then be sure to come to our office the preceding Friday.
- \* **PLEASE NOTE—NEW KEY RULES FOR 2019-20 SEASON:** The \$75 deposit must be put on a credit card (no cash or checks accepted for deposit). Upon return of the key (either to the **drop box** or the attendant at the tollbooth in Millcreek Canyon, or to our office at 6332 S. Airport Road) the deposit will be returned to your card within 3 business days.
