5:40 pm Welcome and Introductions

5:35 pm Approval of Minutes

- February minutes were not approved and were tabled for next meeting due to a lack of majority members at the time of approval.

5:40 pm Public Comments

- Mike Mikhalev made public comments and updates on the Foothill Trails Master Plan.
- Mike Mikhalev requested that the Bonneville Shoreline Trail Advancement Act be placed on the agenda for next month.
- Roger Crandall (representing Real Salt Lake and Rio Tinto stadium) made public comments on proposed bicycle improvements at the stadium.
 - Roger is working with Rio Tinto to add additional bicycle parking facilities at the stadium,
 - Potential creation of a community “ride to the match” event before each game.
 - Jared to email resources to Roger from the County website on design guidelines for bicycle parking.
- Dave Iltis (Cycling Utah) provided updates on the 300 West roadway reconstruction in Salt Lake City and roadway reconstruction on 2000 East near the Parley’s Trail access.
 - Jared to contact Salt Lake County Parks and Recreation to learn about their input on 2000 East connections to the Parleys trail.

- **Tactical Urbanism: (Blair)**
 - SLCBAC partnered with Bike Utah to submit a grant to Bloomberg Philanthropies for a tactical urbanism project in Midvale. There has been no response on this grant application yet.
 - Upcoming events (pending they are not canceled due to the pandemic) may provide additional opportunities for tactical urbanism. These include the Bike Summit and a tactical urbanism event in September related to the 300 West roadway improvements.
- **Golden Spoke Event Opportunity & Bike Month: (Blair)**

- No updates currently. Blair will continue to coordinate with the planning committee and inform the group of updates at the next meeting.
- **Dimple Dell Active Transportation Updates: (Erik)**
 - Sandy will be push any Dimple Dell planned improvements into the Sandy/Draper combined Active Transportation Plan.
 - SLCBAC will coordinate with Sandy/Draper to connect Alex Parker and Dixie to allow them to participate in the planning process more.
- **Bicycle Signage and Repair Station updates: (Jared)**
 - Bicycle repair station is being approved for installation officially by the Salt Lake County Council and by Murray. Next, Salt Lake County and Cottonwood Heights will enter into an agreement to have Cottonwood Heights maintain and install the station.
- **Mid Valley Active Transportation Plan: (Erik)**
 - Updates on the mission and goals of the Mid Valley Active Transportation Plan, which includes the cities of Cottonwood Heights, Millcreek, Holladay, Midvale, and Taylorsville.

- Jared provided legislative updates on HB 133 and HB 24:
 - HB 133 expands the uses of eminent domain to include trails
 - HB 26 appropriates money for improvements along the Jordan River Parkway
- Provided the typical meeting schedule for each SLCBAC members city council. Blair assigned SLCBAC members to visit their city council meetings and introduce themselves along with their role in SLCBAC.
