

# Drive-Up Ballot Issuance/Replacement Locations

June 30, 2020

7:00 a.m. – 8:00 p.m.

Primary Ballot Packets will be issued to Salt Lake County registered voters who were eligible to receive a vote-by-mail ballot but did not get one. There will not be voting conducted at these locations. The rules below will apply to the Drive-Up Ballot Issuance/Replacement Locations:

- **Voter registration will not be conducted at Drive-Up Ballot Issuance/Replacement Locations.**
- **Party affiliations cannot be changed from one party to another at these locations on Election Day.**
- **Republican Primaries – statewide/countywide**  
Unaffiliated voters will be required to affiliate with the Republican Party to be issued a Republican Primary Ballot Packet.
- **Democratic Primaries – occurring in two districts**  
Unaffiliated voters who reside within the two districts where primaries are occurring may be issued a Democratic Ballot Packet without affiliating, or they may choose to affiliate.  
(Salt Lake County Council District #6 and Utah House of Representatives District #33)
- **Non-Partisan Local School Board Primaries – four local school board districts**  
Ballot packets will be issued to eligible voters who reside within the four applicable districts.  
(Granite School Board Districts #1 & #2 and Salt Lake School Board District #1 – Salt Lake School Board District #5 Primary canceled due to the elimination of a candidate.)
- **Ballots issued at Drive-Up Locations cannot be mailed**  
They will need to be deposited at a ballot drop box by 8:00 pm to be counted.
