2023 Budget Goals

- Maintain structural balance in 2023 and ongoing
 - Match one-time projects with one-time federal revenues
- Prepare County for 2024 and inflationary cost pressures
- Continue to review ARPA lost revenue analysis to draw down ARPA





2023 June Budget Direction

- Focus on technical adjustments
- New requests must be exigent
- ARPA/TI projects treated like capital projects true ups
 - Ops and capital rolled over
 - Personnel under spend reverts to fund balance







Highlights for June 2023

- Salt Lake County employment is strong
- Tax and operating revenues plateauing or slightly declining
- Additional inflationary pressures expected for 2024 budget
- Certified Property Tax Rates not available until approx. June 13th





American Rescue Plan Act

 - \$112.7M received 6/6/2021
 - \$112.7M expected 6/2022

Visit Salt Lake

- Increased statutory marketing budget by \$685K due to TRT revenue increases
- Continuing the plan for the CTAA
- New FTE in Treasurer's office paid for out of the revenues of the CTAA to manage the collection





Human Resources

- Requesting 3 FTE necessary to meet customer demand
 - In part at the request of elected officials
 - Matches the need expressed in the customer survey

Mayor's Finance

- MFA expects four accounting retirements within the next 8 months
- The entire ESR staff will be turned over
- Justice Courts may need accounting assistance during its transitionary period
- Requesting to double-fill two accounting positions in preparation for these events





Justice Courts

- Reduced 5 FTE for migration of Millcreek to the Holladay/Cottonwood Heights Justice Court
- Net increase of \$561K
- Finance team stands ready to assist the court and analyze the budget as we move forward

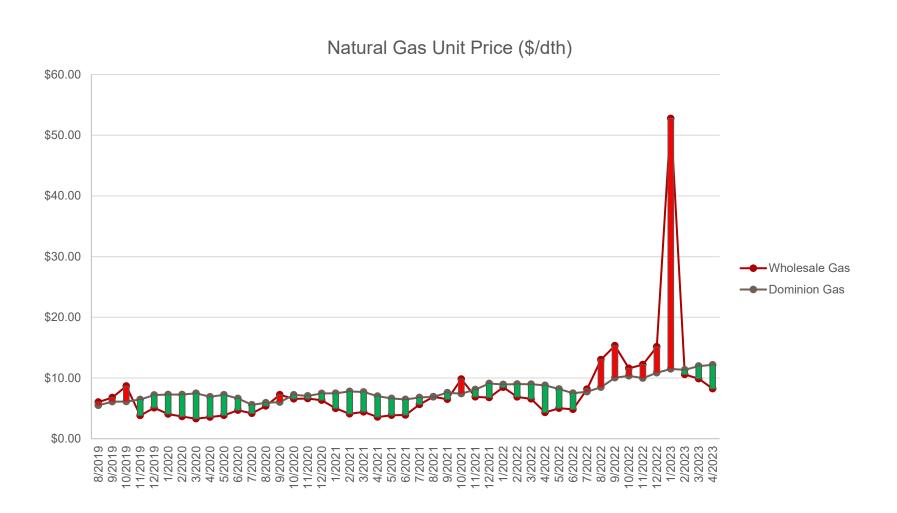

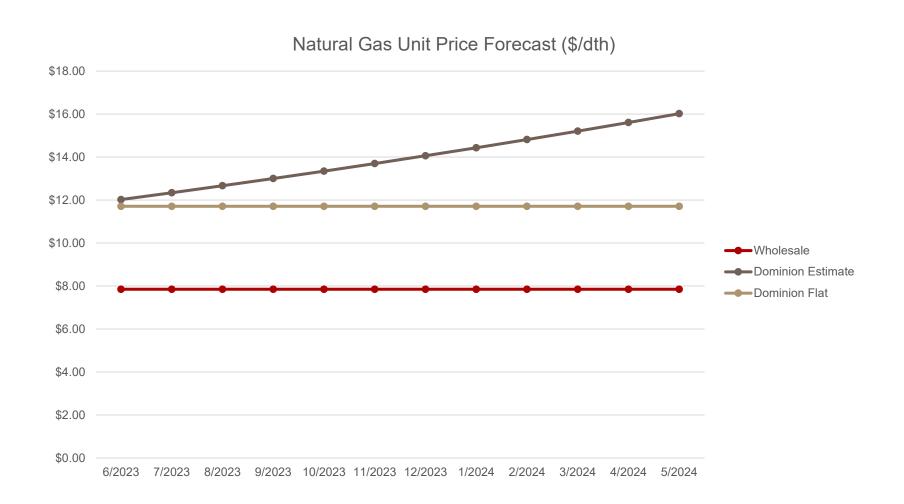

- 39% of TRCC revenues to Parks and Recreation Ops
- Proposed ending fund balance \$13.1M

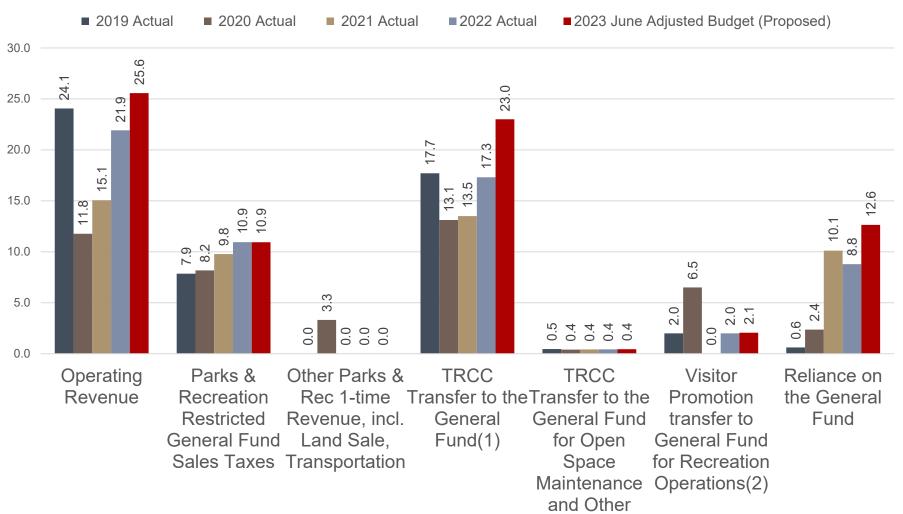

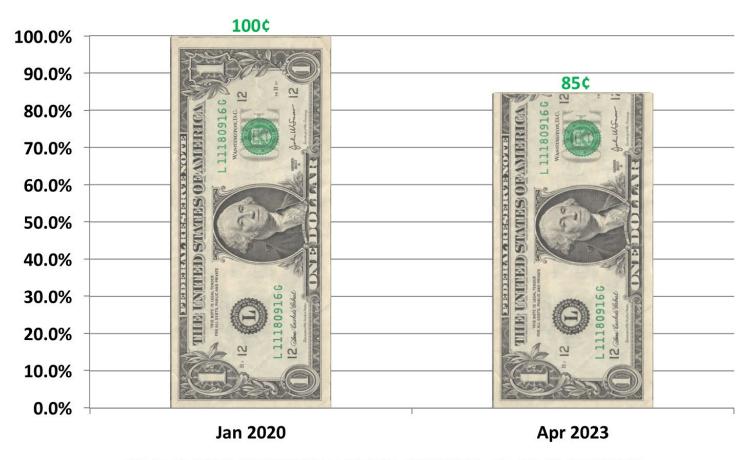

Purchasing Power Erosion Due to Inflation

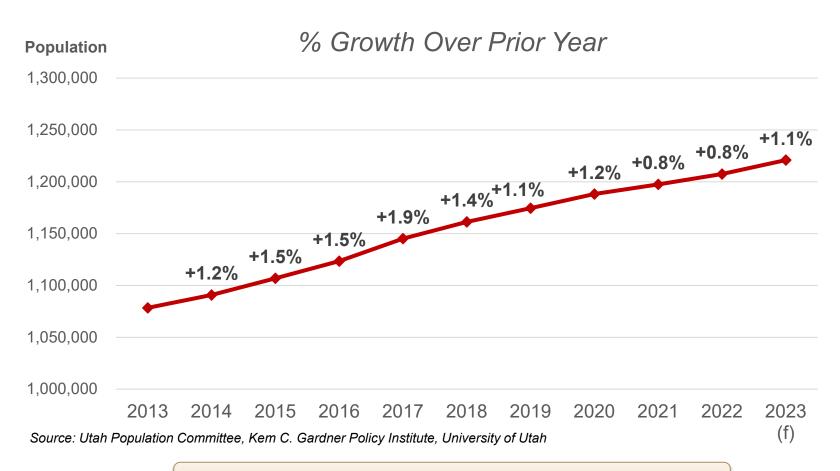


INFLATION INDEX: WEST URBAN CONSUMER PRICE INDEX - ALL URBAN CONSUMERS

2023 Budget Recap

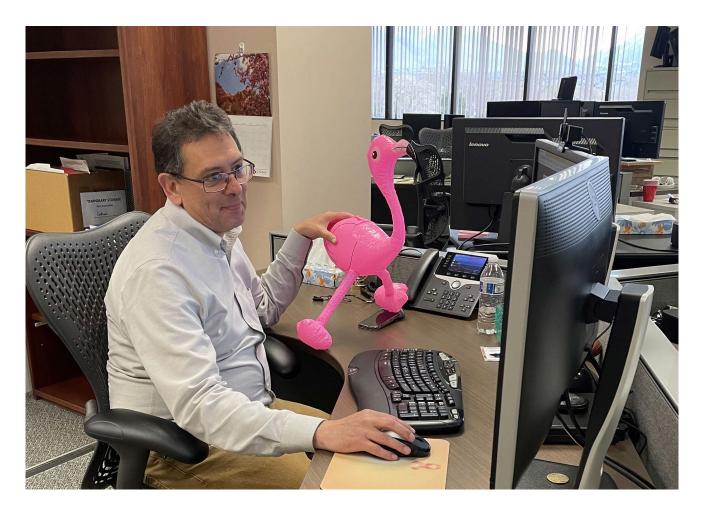
All Funds

- All funds are balanced
- Net appropriations at approximately \$1.91 B
- We recommend ratifying all previously approved interim budget adjustments for formal adoption
- Certified tax rates not available until approximately June 14th
- Next Steps
 - Monthly sales tax revenue reporting to continue
 - Track structural balances
 - Continue to monitor inflation and impacts on expenditures, particularly wages
