• **State and Local School Board Candidates, Metro Townships – Council Candidates, Millcreek City Mayor and City Council Candidates:**

The Declaration of Candidacy filing period for state and local school board candidates, metro townships – board candidates, and Millcreek City mayor and city council candidates begins on Monday, January 4, 2016 and ends at 5:00 p.m., Thursday, March 17, 2016.

• **Judicial Retention – District Court Judges, Juvenile Court Judges and Justice Court Judges:**

The Declaration of Candidacy filing period for justices and judges of a court of record begins Friday, April 1, 2016 and ends at 5:00 p.m., Friday, April 15, 2016.
