Please complete the questionnaire below and return it within 10 days. We must have all questionnaires returned regardless of the circumstances. If you have any questions regarding qualifications, write the information on this form indicating the problem. If a person is unable to complete the form, another person may do so indicating who completed the form and the reason. **Failure to complete and return the questionnaire will subject you to penalties provided by law.**

**ACCESS TO JURY SERVICE IS AVAILABLE TO ALL QUALIFIED INDIVIDUALS WITH DISABILITIES AS REQUIRED BY THE AMERICANS WITH DISABILITIES ACT. IF YOU HAVE A DISABILITY AND REQUIRE ACCOMMODATION, YOU SHOULD CONTACT THE COURT AFTER BEING SUMMONED FOR JURY SERVICE.** If you have a question, you may call (385) 468-8200.

A person summoned for jury service who fails to appear or to complete jury service as directed shall be ordered by the court to immediately appear and show cause for failure to comply with the summons. (78-46-20)

An employer shall not deprive an employee of employment or threaten the employee with dismissal for reporting to jury service. (78-46-21)

Any person who willfully misrepresents a material fact on a juror qualification form may be punished upon conviction by a fine of not more than \$500 or imprisoned not more than 5 days, or both. (78-46-12)
