



TOURNAMENT PRICING

(Monday thru Thursday)

- Tournament fees are \$54.00 per player. Includes 18-hole green fees with cart fees and \$6.00 per player in Golf Shop Credit. The credit may be used for merchandise only.
- Shotgun starts begin at 7:30 (Some exceptions for early or late season events). Minimum of 72 players for a shotgun.

(Friday)

- Tournament fees are \$56.00 per player. Includes 18-hole green fees with cart fees and \$6.00 per player in Golf Shop Credit. The credit may be used for merchandise only.
- Shotgun starts begin at 7:30 (Some exceptions for early or late season events). Minimum of 72 players for a shotgun.

(Saturday & Sunday)

- Tee Time Fees 18 holes, \$60.00 per player. Includes green fees, cart fees and \$10.00 per player in Golf Shop credit. The credit may be used for merchandise only.
- Shotgun starts are at 7:30 am.

TOURNAMENT POLICIES AND INFORMATION

- All advance reservations must be paid in full ten (10) days prior to the event. Credit card number or payment by check will be required at this time. Only paid times will be held.
- A list of players will be required two (2) days in advance. Any changes must be finalized no later than 12pm the day prior to the event.
- No outside food and beverage will be allowed. Please contact our food and beverage coordinator: Kaylyn Tafoya @ 385-468-1431 or kaylyn@oldmillclubhouse.com for any arrangements or questions.
- On course special requests for a tournament must be emailed to the Superintendent (Leslie Varoz at lvaroz@slco.org) or the Head Professional (Brian Schramm at bschramm@slco.org) within 24-48 hours prior to the tournament date. Examples: Closest to Pin Circles, Straightest Drive Line, Pin Placement, Tee Yardage, Tents, Tables, Chairs, Fixtures, and Automobiles. *Any requests made the day of a tournament may not be fulfilled.*
- Tee time starts are available. Please contact the golf course for details and availability.

- Rental clubs are available upon request. Please allow seven (7) day notice for rentals.
- The staff at The Old Mill Golf Course must approve any and all special requests which may include closest to the hole circles on par 3's, straight line markings in the fairways and any specific yardage requests on par 3's for prize giveaways.
- Any vehicles that require access on the golf course must be escorted by Maintenance Personnel only!!
- On Monday, Wednesday and Fridays, we ask that any tents, tables or chairs not be placed on tee box areas until 9:00 A.M to allow maintenance personnel to finish mowing.
- All signs, banners or excessive trash must be removed from golf course at the conclusion of the tournament.
