

Solicitor License Application

WRITTEN DISCLOSURE

1. The applicant's submission of the application authorizes the County to verify information submitted with the completed application including:
 - a. Applicant's address; and
 - b. Applicant's and /or responsible person or entity's State Tax Identification and special use tax number, if any; and
 - c. The validity of applicant's proof of identity.
2. The County may consult any publicly available sources for information on any applicant, including but not limited to, databases for any outstanding warrants, protective orders, or civil judgments.
3. Proof of identity is required before registration is allowed.
4. The fee amount of \$65.00 must be submitted by applicant with a complete application.
5. Applicant must submit a BCI background check no older than 180 days prior to date of application.
6. To the extent permitted by State and/or Federal law, applicant's BCI background checks shall remain confidential, protected, private records not available for public inspection.
7. The County will maintain copies of applicant's application form, proof of identity and identification badge. These copies will become public records available for inspection on demand at the County offices whether or not certificate is denied, granted, or renewed.
8. Please refer to Section V of the Solicitor License Application for disqualifying status and Title 5, Chapter 130, Salt Lake County Code of Ordinances, 2001 for approval or denial of the application.
9. A temporary certificate will be granted or denied the same business day that a completed application is submitted.
