- Road projects that may present opportunities to enhance bicycling accommodations.

We will be reviewing the various maps which have been previously prepared which should facilitate this process: S L County Bicycle Map, WFRM Regional Bike Map, previous SLCBAC bike route study, County Cooperative Plan Bike Route Map. Note this will be an ongoing process which will eventually include the County Township and Community General Plans.
